Appendix: 2024 Report on Single and Sole-Source Contracts

Single and sole sourcing, in the right circumstances, can both be legitimate and useful procurement tools that can reduce costs, improve efficiencies and ensure quality.

Sole sourcing occurs when a purchase is made from the only available supplier for the required item(s) or service. Sole sourcing includes standardization decisions where a particular specification has been established that can only be met by a single vendor.

Single sourcing occurs when a purchase made from a particular supplier, purposefully chosen without a competitive process, when other suppliers are available. An example of a single source would be procuring services from an incumbent vendor, without a competitive process. This may occur in the case of an extension to an existing contract.

In general, the Airport Authority's procurement of goods and services will be awarded following a competitive process, however there are exceptions where a single or sole source may provide the best route to achieving best overall value. Exceptions to the competitive process approach may be made in the circumstances described below. The persons with the appropriate signing authority will state in writing upon what grounds the exception is being made.

Reasons for exceptions include:

- 1. The goods or services are of a proprietary nature or there is only one qualified supplier
- 2. Urgency arising from a safety, security or critical operating need
- 3. In compliance with a product, services or equipment standardization program

4. When the supplier has satisfactorily performed previous related services that provided a cost saving or value add

5. Strategic third-party arrangement with business partner


6. The supplier has been awarded a contract for a similar product or service by the Airport Authority as the result of a competitive process within the previous five years.

In keeping with our policy of being transparent, we publish the list of Single and Sole Source Contracts more than \$163,702 (\$100,000 in 2000 dollars) which were not awarded based on a competitive process during 2024.
